- Miscellaneous Federal \$149,064 or 100% (audit reclassification)
- ➤ Tuition from other Co/City (\$93,300) or -100% (non received)
- Tuition Day School/Special Fees- (\$69,190) -99% (only \$50/mo recv'd)
- ➤ Miscellaneous/Recoveries (\$68,701) or -62%
